Conducting internal investigations of employee conduct has been common practice in the U.S. for years, and is only recently becoming a world-wide phenomenon. When grappling with a claim of harassment, discrimination, theft, retaliation, or workplace violence, a multi-national company needs to ensure that its investigation is handled consistently from jurisdiction to jurisdiction and is thorough and professional; otherwise, it faces a real prospect of expensive litigation and significant liability. - Standard of proof – how much evidence you need to decide if misconduct occurred
- Whether the accused has the right to remain silent, to counsel, or to a union representative
- The concrete skills that investigators must possess
- How to obtain meaningful information from the accused and reluctant witnesses
- Addressing concerns about retaliation and confidentiality
- How to arrive at a conclusion that will withstand a legal challenge
